We may share your data only with service providers as necessary to fulfill your requests. Your information will not be sold or shared with third parties for marketing purposes.
- **Data Security:** We protect your data with secure storage measures to prevent unauthorized access. We do not transfer or share your personal information with any external organization under any circumstances. We have strict policies and security measures to prevent unauthorized access or sharing of your data.
- **Data Sharing and Marketing:** We do not share your personal or mobile information with third parties for marketing purposes under any circumstances. Your information is only used for business purposes related to your care and our services.
